**REQUIREMENTS:**

Pursuant to article 109 of the Academic Education Act of the 25<sup>th</sup> July, 2005 (JO 2016, item 1842 ,as amended) admitted to the competition may be a candidate who:

- holds qualifications specified in the Act,
- has full legal capacity,
- has not been penalized by a valid court sentence for an intentional offense,
- has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- is the holder of full public rights

**and complies with requirements specified for the position of *asystent***

- diploma of medical practitioner,
- specialization degree in internal diseases or clinical pharmacology,
- doctoral degree in medical sciences,
- author or co-author of at least 10 publications in reviewed journals (including the minimum of 5 original contributions , among which at least 2 are delivered by the candidate as the main author).
- author of publications scoring the minimum total of 5 IF points

**A candidate willing to take part in the competition is requested to submit:**

1. the written statement of will expressing the intention to participate in the competition, addressed to the Rector, in case of employees of the Medical University of Silesia, attached opinion by the head of the unit,
2. curriculum vitae,
3. copy of the license to perform the profession of a physician,
4. personal questionnaire of the applicant seeking employment,
5. copy of the diploma (academic diploma),
6. copy of a document proving the specialization degree in internal diseases or in clinical pharmacology,
7. copy of a document proving the doctoral degree in medical science,
8. criminal record inquiry,
9. declaration of compliance with requirements defined in article 109 of the Academic Education Act,
10. the statement of consent to process the personal data,

11. declaration of compliance with requirements defined in article 118, par. 7 of the Academic Education Act,
12. declaration of acknowledgement of the Medical University of Silesia as the major employer, as understood by the Academic Education Act, should the candidate be accepted for the position,
13. other relevant documents:
  - list of complete publications quoting the IF scores or the Ministry of Science and Higher Education scheme
  - certificates held.
