Pursuant to article 109 of the Academic Education Act of the 25th July, 2005
(JO 2016, item 1842 ,as amended) admitted to the competition may be a candidate who:

- holds qualifications specified in the Act,
- has full legal capacity,
- has not been penalized by a valid court sentence for an intentional offense,
- has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- is the holder of full public rights

and complies with requirements specified for the position of *wykładowca*

- master degree in the area of pedagogy, specializing in health pedagogy or protective-educational pedagogy,
- experience in academic teaching,
- prepared to carry out teaching programmes with the use of up-to-date methods, with special focus on medical simulation or drama,
- at least 5-year direct pedagogical experience in work with children and parents with health or educational problems,
- motivated for professional development in scientific studies and education.

A candidate willing to take part in the competition is requested to submit:

1. a written statement of will expressing the intention to participate in the competition, addressed to the Rector,
2. curriculum vitae,
3. personal questionnaire of the applicant seeking employment,
4. copy of the diploma (academic diploma),
5. information from the State Record of Convictions,
