(JO 2016, item 1842 ,as amended) admitted to the competition may be a candidate who:

- holds qualifications specified in the Act,
- has full legal capacity,
- has not been penalized by a valid court sentence for an intentional offense,
- has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- is the holder of full public rights

**and complies with requirements specified for the position of *starszy wykładowca***

- master degree in the area of biology,
- doctoral degree in natural sciences,
- long standing teaching experience at a medical university, comprising both, classes held and management of programmes,
- long standing experience in programmes in the area of histology and embryology,
- author or co-author of at least 20 publications in reviewed journals.
- doctoral degree,
- experience in laboratory work – knowledge of methods applied in molecular biology and experience in cell cultures,
- experience in academic teaching of medical programmes,
- publishes and extends own scientific achievements,
- proved teaching and organizational achievements.

**A candidate willing to take part in the competition is requested to submit:**

1. the written statement of will expressing the intention to participate in the competition, addressed to the Rector,
2. curriculum vitae,
3. copy of the license to perform the profession of a physician,
4. personal questionnaire of the applicant seeking employment,
