- has not been penalized by a valid court sentence for an intentional offense,
- has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- is the holder of full public rights

and complies with requirements specified for the position of *starszy wykładowca*

- completed graduate studies at the faculty of medicine or medical analysis,
- doctoral degree in medical sciences in the area of medical biology,
- expertise and teaching experience to hold programmes in anatomy, physiology, pathophysiology, ergonomics, sensorics and fragrances,
- experience in organization of the teaching process,
- skilled to explore biological and medical data,
- skilled to use statistical methods,
- command of MS Office Professional package,
- command of English,
- proved teaching and organizational achievements.

A candidate willing to take part in the competition is requested to submit:

1. the written statement of will expressing the intention to participate in the competition, addressed to the Rector,
2. curriculum vitae,
