- has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- is the holder of full public rights

### and complies with requirements specified for the position of wykładowca

- degree of dental practitioner/stomatologist,
- > specialization degree in periodontology,
- > doctoral degree in medical sciences,
- > experience in scientific work proved by publications and reports in the realm of periodontology,
- > experience in academic teaching in the area of periodontology,
- ➤ academic teaching experience in the area of periodontal diseases and mucosa and gerostomatology,
- > communicative English.

#### A candidate willing to take part in the competition is requested to submit:

- 1. the written statement of will expressing the intention to participate in the competition, addressed to the Rector,

- 3. copy of the license to perform the profession of a physician,
- 4. personal questionnaire of the applicant seeking employment,
