- has not been penalized by a valid court sentence for an intentional offense,
- has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- is the holder of full public rights

**and complies with requirements specified for the position of *wykladowca***

- degree of dental practitioner/stomatologist,
- experience in academic teaching in the realm of conservative dentistry,
- communicative English.
