REQUIREMENTS:

Pursuant to article 109 of the Academic Education Act of the 25th July, 2005 (JO 2016, item 1842 ,as amended) admitted to the competition may be a candidate who:

- ➤ holds qualifications specified in the Act,
- > has full legal capacity,
- > has not been penalized by a valid court sentence for an intentional offense,
- > has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- > is the holder of full public rights

and complies with requirements specified for the position of senior lecturer:

- > university diploma in Medical Analytics,
- ➤ doctoral degree in biological sciences,
- didactic knowledge and experience to conduct classes of anatomy, physiology, pathophysiology, ergonomics and sensorics and odorants for students of pharmacy, medical analytics, biotechnology, cosmetology and biomedical engineering
- > organizational experience covering organization of educational process
- > practical skill of creating at least 10 types of text-based problems,
- > practical knowledge and skills of techniques applied in evaluation of sensory capabilities,
- > practical skill of applying statistical methods,
- > practical skill of using MS Office Professional programs, Statistica and Corel,
- > command of English

- 5. copy of doctoral diploma,
- 6. criminal record inquiry,
- 7. declaration of compliance with requirements defined in article 109 par. 1 of the Academic Education Act,
- 8. the statement of consent to process the personal data,
- 9. declaration of compliance with requirements defined in article 118, par. 7 of the Academic Education Act,
- 10. declaration of acknowledgement of the Medical University of Silesia as the major employer, as understood by the Academic Education Act, should the candidate be accepted for the position,
- 11. other relevant documents:
 - ✓ list of complete publications quoting the IF scores or the Ministry of Science and Higher Education scheme
 - \checkmark certificates held
