- holds qualifications specified in the Act,
- ➢ has full legal capacity,
- ➢ has not been penalized by a valid court sentence for an intentional offense,
- ▶ has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- ➢ is the holder of full public rights

### and complies with requirements specified for the position of starszy wykładowca

- diploma of medical practitioner,
- ➢ doctoral degree in medical sciences,
- > more than 10 years of professional experience,
- > at least 10-year experience in academic teaching of pathomorphological programmes,
- specialization degree in pathomorphology (with special expertise of haemopathology, pathologies of the alimentary tract and juvenile age tumours),
- skilled in aspiration fine needle biopsy.

### A candidate willing to take part in the competition is requested to submit:

- 1. the written statement of will expressing the intention to participate in the competition, addressed to the Rector,
- 2. curriculum vitae,
- 3. copy of the license to perform the profession of a physician,
- 4. personal questionnaire of the applicant seeking employment,
