Pursuant to article 109 of the Academic Education Act of the 25<sup>th</sup> July, 2005  
(JO 2016, item 1842 ,as amended) admitted to the competition may be a candidate who:

- holds qualifications specified in the Act,
- has full legal capacity,
- has not been penalized by a valid court sentence for an intentional offense,
- has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- is the holder of full public rights

**and complies with requirements specified for the position of *asystent*,**

- diploma of medical practitioner or doctoral degree in medical sciences,
- specialization degree in neurology or ongoing procedures for the specialization degree in neurology,
- experience in academic teaching,
- experience in scientific research,
- advanced command of spoken and written English.

**A candidate willing to take part in the competition is requested to submit:**

1. the written statement of will expressing the intention to participate in the competition, addressed to the Rector,
2. curriculum vitae,
3. copy of the license to perform the profession of a physician,
4. personal questionnaire of the applicant seeking employment,
5. copy of the diploma (academic diploma),
6. copies of other documents to prove the required qualifications,
7. criminal record inquiry,
