- has not been penalized by a valid court sentence for an intentional offense,
- has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- is the holder of full public rights

## and complies with requirements specified for the position of asystent

- > graduate of the faculty of medicine or public health or neurobiology or psychology or medical rescue of finance and management in health care,
- > completed training programmes in the area of experiments with animals,
- > fluent command of English,
- ➤ academic teaching experience to carry out programmes for the students of medicine and dentistry,

- 1. the written statement of will expressing the intention to participate in the competition, addressed to the Rector,
- 2. curriculum vitae,
- 3. copy of the medical practitioner licence
- 4. personal questionnaire of the applicant seeking employment,

- 7. criminal record inquiry,
