REQUIREMENTS:

Pursuant to article 109 of the Academic Education Act of the 25th July, 2005 (JO 2017, item 2183, as amended) admitted to the competition may be a candidate who:

- holds qualifications specified in the Act,
- ▹ has full legal capacity,
- ▶ has not been penalized by a valid court sentence for an intentional offense,
- ▶ has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- ➢ is the holder of full public rights

and complies with requirements specified for the position of *adiunkt*:

- master degree in biology
- doctoral degree in medical sciences in the area of medical biology,
- academic teaching experience in the area of molecular biology and genetics, as preferred by an academic school of medical profile,
- author or co-author of at least 10 publications in reviewed journals (including at least 5 original contributions with at least 2 delivered as the main author).
- > scientific achievements with publications in medical journals scoring at least IF 5.
- experience in scientific studies in the area of molecular biology of nucleic acids and proteins documented by at least 10 publications,
- documented experience in management of small teams (head of research team, etc.).

A candidate willing to take part in the competition is requested to submit:

- 1. a written statement of will expressing the intention to participate in the competition, addressed to the Rector,
- 2. curriculum vitae,
- 3. personal questionnaire of the applicant seeking employment,
- 4. copy of the diploma (academic diploma),
- 5. copies of other documents to prove the required qualifications,
- 6. criminal record inquiry,

- 7. declaration of compliance with requirements defined in article 109 par. 1 of the Academic Education Act,
- 8. the statement of consent to process the personal data,
- 9. declaration of compliance with requirements defined in article 118, par. 7 of the Academic Education Act,
- 10. declaration of acknowledgement of the Medical University of Silesia as the major employer, as understood by the Academic Education Act, should the candidate be accepted for the position
- 11. other relevant documents:
 - list of complete publications quoting the IF scores or the Ministry of Science and Higher Education scheme
 - certificates held
