REQUIREMENTS:

Pursuant to article 109 of the Academic Education Act of the 25th July, 2005
(JO 2017, item 2183 ,as amended) admitted to the competition may be a candidate who:

- holds qualifications specified in the Act,
- has full legal capacity,
- has not been penalized by a valid court sentence for an intentional offense,
- has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- is the holder of full public rights

and complies with requirements specified for the position of *professor nadzwyczajny*

- at least the degree of habilitated doctor,
- scientific achievements since the conferral of the habilitated doctor degree including publications scoring the total of at least 100 parametric points, including at least IF 10.
- held responsibilities of a supervisor of at least one doctoral dissertation with the doctoral degree conferred before submission of documents for the competition procedures,
- at least 3-year professional experience dating from the conferral of the habilitated doctor degree,
- significant and creative scientific and professional achievements,
- knowledge and skills of molecular biology techniques,
- experience in management of research teams in the area of molecular studies,
- experience in academic teaching, including documented programmes held in Polish and a foreign language,
- excellent command of spoken and written English.
- scientific achievements with publications in medical journals scoring at least IF 40.

A candidate willing to take part in the competition is requested to submit:

1. a written statement of will expressing the intention to participate in the competition, addressed to the Rector,
2. curriculum vitae,
3. personal questionnaire of the applicant seeking employment,
4. copy of the diploma (academic diploma),
