REQUIREMENTS:

Pursuant to article 109 of the Academic Education Act of the 25th July, 2005 (JO 2017, item 2183 ,as amended) admitted to the competition may be a candidate who:

- ➤ holds qualifications specified in the Act,
- has full legal capacity,
- has not been penalized by a valid court sentence for an intentional offense,
- has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- is the holder of full public rights

and complies with requirements specified for the position of asystent:

- raduate education in the area of medicine, nursing, public health or other discipline applicable in health care or biotechnology,
- good command of English,
- interest in academic teaching and scientific studies.

A candidate willing to take part in the competition is requested to submit:

- 1. a written statement of will expressing the intention to participate in the competition, addressed to the Rector,
- 2. curriculum vitae,
- 3. copy of the licence of medical practitioner (if applicable),
- 4. copy of licence to practice the profession of a nurse (if applicable),
- 5. personal questionnaire of the applicant seeking employment,
- 6. copy of the diploma (academic diploma),
- 7. copies of other documents to prove the required qualifications,
- 8. criminal record inquiry,
- 9. declaration of compliance with requirements defined in article 109 par. 1 of the Academic Education Act,
- 10. the statement of consent to process the personal data,
- 11. declaration of compliance with requirements defined in article 118, par. 7 of the Academic Education Act.

- 12. declaration of acknowledgement of the Medical University of Silesia as the major employer, as understood by the Academic Education Act, should the candidate be accepted for the position
- 13. other relevant documents:
 - list of complete publications quoting the IF scores or the Ministry of Science and Higher Education scheme
 - certificates held
