Pursuant to article 109 of the Academic Education Act of the 25<sup>th</sup> July, 2005  
(JO 2017, item 2183 ,as amended) admitted to the competition may be a candidate who:

- holds qualifications specified in the Act,
- has full legal capacity,
- has not been penalized by a valid court sentence for an intentional offense,
- has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- is the holder of full public rights

**and complies with requirements specified for the position of *asystent***

- master degree in medical analytics
- co-author of at least one publication in a journal specified in Philadelphia List,
- experience in carrying our scientific studies and/or management of research projects in the area corresponding to the profile of the Chair,
- experience in academic teaching.

**A candidate willing to take part in the competition is requested to submit:**

1. a written statement of will expressing the intention to participate in the competition, addressed to the Rector,
2. curriculum vitae,
3. personal questionnaire of the applicant seeking employment,
4. copy of the diploma (academic diploma),
