- has not been penalized by a valid court sentence for an intentional offense,
- has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- is the holder of full public rights

### and complies with requirements specified for the position of asystent

- master degree in pharmacy,
- > at least 5-year experience as a pharmacist,
- knowledge of pharmacology, including interactions, contraindications and adverse effects,
- > very good recognition of drug technologies and pharmaceutical recipe.
- > command of KAMSOFT software,
- knowledge of English at least at B2 level,
- > experience in team work,
- > experience in academic teaching.
