(JO 2017, item 2183 ,as amended) admitted to the competition may be a candidate who:

- holds qualifications specified in the Act,
- has full legal capacity,
- has not been penalized by a valid court sentence for an intentional offense,
- has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- is the holder of full public rights

**and complies with requirements specified for the position of *asystent***

- master degree in pharmacy,
- at least 5-year experience as a pharmacist,
- knowledge of pharmacology, including interactions, contraindications and adverse effects,
- very good recognition of drug technologies and pharmaceutical recipe.
- command of KAMSOF software,
- knowledge of English at least at B2 level,
- experience in team work,
- experience in academic teaching.
