REQUIREMENTS:

Pursuant to article 109 of the Academic Education Act of the 25th July, 2005 (JO 2017, item 2183, as amended) admitted to the competition may be a candidate who:

- holds qualifications specified in the Act,
- ➢ has full legal capacity,
- ➢ has not been penalized by a valid court sentence for an intentional offense,
- ▶ has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- ➢ is the holder of full public rights

and complies with requirements specified for the position of asystent

- diploma of medical practitioner,
- > doctoral degree in medical sciences or student of doctoral programme,
- > specialization degree in diabetology or ongoing procedures for the degree,
- > author or co-author of more than 5 scientific contributions (total Ministry of Science and Higher Education score > 40), including at least one publication with IF > 1.0,
- ➢ good command of English,
- > interest in academic teaching and scientific studies.

A candidate willing to take part in the competition is requested to submit:

- 1. a written statement of will expressing the intention to participate in the competition, addressed to the Rector,
- 2. curriculum vitae,
- 3. copy of the medical practitioner licence,
- 4. personal questionnaire of the applicant seeking employment,
- 5. copy of the diploma (academic diploma),
- 6. copies of other documents to prove the required qualifications,
- 7. criminal record inquiry,
- 8. declaration of compliance with requirements defined in article 109 par. 1 of the Academic Education Act,

- 9. the statement of consent to process the personal data,
- 10. declaration of compliance with requirements defined in article 118, par. 7 of the Academic Education Act,
- 11. other relevant documents:
 - list of complete publications quoting the IF scores or the Ministry of Science and Higher Education scheme
 - certificates held
