REQUIREMENTS:

Pursuant to article 109 of the Academic Education Act of the 25th July, 2005
(JO 2017, item 2183) admitted to the competition may be a candidate who:

- holds qualifications specified in the Act,
- has full legal capacity,
- has not been penalized by a valid court sentence for an intentional offense,
- has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- is the holder of full public rights

and complies with requirements specified for the position of *wykładowca*

- at least master degree in the area of nursing,
- licence to practice the profession of a nurse,
- experience in academic teaching,
- at least 5-year professional nursing experience in paediatric medical centres.

A candidate willing to take part in the competition is requested to submit:

1. the written statement of will expressing the intention to participate in the competition, addressed to the Rector,
2. curriculum vitae,
3. personal questionnaire of the applicant seeking employment,
4. copy of the diploma (academic diploma),
5. copy of the licence to practice the profession of a nurse,
6. copies of other documents to prove the required qualifications,
7. criminal record inquiry,
8. declaration of compliance with requirements defined in article 109 par. 1 of the Academic Education Act,
9. the statement of consent to process the personal data,
