REQUIREMENTS:

Pursuant to article 109 of the Academic Education Act of the 25th July, 2005
(JO 2017, item 2183 ,as amended) admitted to the competition may be a candidate who:

- holds qualifications specified in the Act,
- has full legal capacity,
- has not been penalized by a valid court sentence for an intentional offense,
- has not been penalized by a disciplinary penalty as referred to in art. 140 par. 1. item 4,
- is the holder of full public rights

and complies with requirements specified for the position of *asystent*

- diploma of medical practitioner,
- doctoral degree in medical sciences,
- specialization degree in cardiology,
- advanced command of English to hold programmes for the students,
- knowledge and academic teaching experience to hold programmes for the students,
- publications in reviewed medical journals, chapters in textbooks, presentations at congresses and conferences (not a prerequisite, nevertheless an asset).

A candidate willing to take part in the competition is requested to submit:

1. a written statement of will expressing the intention to participate in the competition, addressed to the Rector,
2. curriculum vitae,
3. copy of the medical practitioner licence,
4. personal questionnaire of the applicant seeking employment,
5. copy of the diploma (academic diploma),
6. copies of other documents to prove the required qualifications,
7. criminal record inquiry,
8. declaration of compliance with requirements defined in article 109 par. 1 of the Academic Education Act,
9. the statement of consent to process the personal data,
