**Announces a competition for a position of UMCS Professor (scientific-didactic employees group) in Department of Media Communication of Institute of Social Communication and Media Sciences at Faculty of Political Science and Journalism**

Competition is open for anyone who meets the conditions set in the *higher education and science acts* of 20 July 2018 (t. j. Dz. U. z 2020 r. poz. 85 ze zm.) as well as UMCS Statute of 29 May 2019 with chg.

**I. COMPETITION CRITERIA ARE AS FOLLOWS:**

- possession of a scientific title of doctor of humanities in the field of linguistics;
- considerable scientific achievements, especially scientific monographs, scientific articles published in leading scientific journals, articles in reviewed post-con materials in terms of public language, verbal communication, pragmatics & semantics of Polish language;
- considerable didactic and organisational activity related to promotion of public language;
- candidates who went through and passed habilitation process are required to promote at least one doctorate or prepare at least one review in a habilitation or doctoral process or gain external funds for scientific or didactic activity at the University;
- moreover, candidates with their scientific title of doctor are required to possess exceptional scientific achievements, having lead a team that realized an international or national scientific project granted by central institutions in a competition procedure as well as having gained external funds for scientific activity at the University.

**II. AN ENTRY SHOULD CONTAIN:**

- an application addressed to HM UMCS Rector;
- copy of a doctoral diploma or any other document confirming the possession of a scientific title of doctor;
- personal questionnaire and resume;
- list of scientific publications;
- list of scientific, didactic and organisational achievements;
- references in predispositions to work as an academic teacher;
- statement concerning meeting the requirements in accordance with art. 113 of the *higher education and science acts* of 20 July 2018 (t. j. Dz. U. z 2020 r. poz. 85 ze zm.)
- statement of a candidate confirming that UMCS will be the main source of employment;
- statement of a candidate confirming his approval for processing of their personal data in accordance with art. 6 ust. 1 lit. a) of ordinance of the European Parliament and Council (UE) 2016/679 of 27 April 2016 r. of protection of natural persons according to personal data procession and free transfer of such data and repeal of 95/46/WE directive (general ordinance of personal data protection)

- contract of employment, **beginning 1 February 2021 for an indefinite period**, full-time work in the **main** source of employment..

Maria Curie-Skłodowska University in Lublin located at Pl. Marii Curie - Skłodowskiej 5, 20-031 Lublin (UMCS) informs that any data collected in the recruitment process will only be processed to conduct the recruitment.

Any person participating in the recruitment process must provide their data in the field resulting from art. 22 <sup>1</sup> KP as well as detailed laws related to employment at a specific position. Providing data in any wider range than the one required by law is voluntary. Data procession is based on law and consent in respect of data extending the field set by law.

Based on art. 7 ust. 3 of general ordinance of personal data protection, in respect of data extending the field set by law, any data subject has full right to withdraw their consent at any moment, however, such withdrawal does not influence the legality of any procession that took place before the withdrawal.

Based on art. 15-21 & art. 77 of general ordinance of personal data protection, any data subject has full right to access, correct, delete or limit the processing of said data as well as right to object the procession, raise a complain to supervisory authority as well as right to move the data. Any personal data that was collected will not be subjected to sale or sharing to any third parties, excluding the ones authorized by law, the data will also not be shared with any states or organisations against the rules set by the general ordinance of personal data protection.

Said data will be processed by UMCS during the recruitment period. Data processed due to a consent will be processed until the eventual objection or withdrawal of said consent and after that period – for archiving purposes, in accordance with UMCS procedures as well as to meet goals and in a period and field required by the law to secure any eventual claims.
