 - list of received awards and distinctions.
- 2. Application to the Rector-Commandant for the post.
- 3. Copies of diplomas/degrees.
- 4. A statement that the War Studies University will be the primary place of employment.
- 5. Declaration of having full legal capacity, statement of no criminal record by a final court judgment for an intentional crime, statement of no disciplinary penalties resulting in deprivation of the right to pursue the profession of academic teacher for a permanent or fixed period and declaration on exercising full public rights.
- 6. Declaration on having on close family relations with the direct superior.
- 7. Declaration of consent to the processing of personal data contained in the job offer in accordance with the Act of May 10, 2018, Journal of Laws 2018 of 2018.05.24, item 1000, On the protection of personal data, with the following content: "I hereby give consent to the processing of my personal data for the purposes of the recruitment

- fluent Polish and one foreign language at least.
