The candidate should fulfill the following conditions:

- 1) possession of a PhD title in the discipline of automatics, electronics, electrical engineering and space technologies,
- 2) knowledge of scientific issues, confirmed by publications, projects, diploma theses, or presentations at conferences covering the issues of: modeling and simulation, vehicle automation, software engineering, automotive ICT systems,
- 3) authorship or co-authorship of articles with IF covering the above-mentioned scientific issues,
- 4) authorship or co-authorship of patent applications covering the above-mentioned scientific issues,
- 5) working knowledge of programming and test-driven development,
- 6) ability to analyze and design analog-digital circuits,
- 7) experience in conducting didactic classes in the field of control theory and self-driving vehicles,
- 8) experience in the implementation of research and development projects, project management,
- 9) documented activity in international non-profit professional organizations (IEEE, SAE, etc.),
- 10) experience in developing industry standards,
- 11) knowledge of design principles in accordance with the 6 σ methodology,
- 12) experience in organizing and managing large data sets,
- 13) experience in Digital Signal Processing with focus to Software Defined Radio,
- 14) knowledge of the English language at a level at least B-2 enabling the analysis and editing of scientific texts and conducting didactic classes,
- 15) knowledge of the Polish language to a degree enabling: preparation of teaching materials (instructions, scripts) and conducting classes (laboratories, lectures), candidates who are not Polish citizens should attach a certificate of knowledge of the Polish language at least at C-1 level,
- 16) predispositions and passion for scientific and didactic work,
