**II) Job Offer description:** research and didactic position of Assistant Professor located at the Department of Computational Biology in the Institute of Molecular Biology and Biotechnology at the Faculty of Biology

#### III) Requirements and qualifications:

The competition is open to individuals who meet the requirements specified in Article 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2023, item 742 ze zm.) and who meet the following requirements:

- 1. PhD A doctoral degree in the field of biological, medical, or related sciences;
- 2. at least 5 years of documented experience in the fields of bioinformatics / computational biology, and genomics;
- an excellent scientific track record in bioinformatics / computational biology, and genomics, demonstrated through authorship of publications in leading scientific journals;
- 4. documented experience in the use of advanced computational methods for the analysis of genomic data;
- 5. completed foreign scientific internship encompassing various aspects of genomics;
- 6. experience in conducting scientific research in collaboration with business entities;
- 7. a track record of successfully obtaining national or international grants for scientific research;
- 8. basic laboratory skills in molecular biology and molecular genetics;
- 9. at least 3 years of experience in teaching bioinformatics to students;
- proficiency in working with modern nucleic acid sequencing systems is an advantage;
- 11. fluent proficiency in both spoken and written Polish and English languages.

- 1. scientific achievements documented by publications and their compliance with the research area competition requirements (0-20 pts);
- 2. research projects managing (0-5 pts);
- 3. participation in postdoctoral internships (0-5 pts);
- 4. participation in research projects; participation in trainings and workshops; participation in conferences and scientific seminars (0-5 pts);
- 5. experience in teaching at the academic level; compliance of the candidate's teaching skills with the didactic activity of the Faculty of Biology; readiness to conduct classes in Polish and English (0-5 pts).

## VIII) The selection process:

- 1. competition committee begins working no later than 14 days after the deadline for submission of documents;
- 2. formal evaluation of submitted proposals;
- 3. call to provide additional or missing documents if necessary;
- 4. selection of candidates for the interview stage;
- 5. interviews for candidates who meet the formal requirements;
- 6. the committee has the right to request external reviews of candidates' work or to ask candidates to conduct teaching assignments with an opportunity for student evaluation;
- 7. the chair of the competition committee announces the results and informs the candidates; this information will include justification with a reference to candidates' strengths and weaknesses; submitted documents will be sent back to candidates (not applicable for documents sent by e-mail).
