**II) Job Offer description:** research and didactic position of Assistant Professor located at the Department of Plant Ecophysiology in the Institute of Experimental Biology at the Faculty of Biology

### III) Requirements and qualifications:

The competition is open to individuals who meet the requirements specified in Article 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2023, item 742 as amended) and who meet the following requirements:

- 1. PhD degree in biological sciences or relevant;
- very good scientific achievements documented by the authorship of papers published in leading scientific journals in the field of plant pathophysiology and mechanisms of plant resistance to biotic and abiotic stresses;
- 3. experience in obtaining funds for research and implementation of research projects;
- 4. good knowledge of the Polish language in speech and writing
- 5. good knowledge of the English language in speech and writing;
- 6. experience in the field of in vitro cultivation techniques of phytopathogens;
- 7. ability to plan and conduct experiments in the plant-pathogen system;
- 8. mastered research techniques in the field of:
  - assessment of the degree of plant infection by phytopathogens
  - isolation and purification of DNA, RNA, mRNA
  - gene expression analysis, using real-time RT-PCR and PCR
  - detection of post-translational modifications
  - measurement of the level of signaling molecules, including reactive nitrogen species
  - immunohistochemical analysis

- 4. participation in research projects; participation in trainings and workshops; participation in conferences and scientific seminars (0-5 pts);
- 5. experience in teaching at the academic level; compliance of the candidate's teaching skills with the didactic activity of the Faculty of Biology; readiness to conduct classes in Polish and English (0-5 pts).

# VIII) The selection process:

- 1. competition committee begins working no later than 14 days after the deadline for submission of documents;
- 2. formal evaluation of submitted proposals;
- 3. call to provide additional or missing documents if necessary;
- 4. selection of candidates for the interview stage;
- 5. interviews for candidates who meet the formal requirements;
- the committee has the right to request external reviews of candidates' work or to ask candidates to conduct teaching assignments with an opportunity for student evaluation;
- 7. the chair of the competition committee announces the results and informs the candidates; this information will include justification with a reference to candidates' strengths and weaknesses; submitted documents will be sent back to candidates (not applicable for documents sent by e-mail).
