### **DESCRIPTION (field, expectations, comments, requirements):**

The Dean of the Faculty of Humanities at AGH University of Krakow announces a contest for the position of research assistant in the Department of Society and Technology Studies. The candidate should/should meet the conditions specified in the Law of July 20, 2018. – Law on Higher Education and Science (i.e., Journal of Laws of 2023, item 742, as amended).

Terms and conditions of employment and pay according to the current Law with doctoral network measures doctoral network under the Program HORIZON-MSCA-2022-DN-01.

### **Employment for project Zero-CO2 cement through carbonation of calcium Silicates and aluminates/ DC 8: The social life of calcium carbonate cements**

Employment period: 36 months, full-time.

#### **REQUIREMENTS:**

- 1) master's degree, master's degree in engineering or equivalent,
- 2) not having a doctoral degree at the time of recruitment (definition of "early stage researcher" - ESC),
- 3) meeting AGH University Doctoral School requirements for doctoral student (person employed at the post have to be enrolled in PhD programme until the end of year 2024),
- 4) meeting MSCA requirements, including the MOBILITY principle - at the time of recruitment, the scientist cannot stay in Poland longer than 12 months in the last 3 years counting until the closing date of the contest,
- 5) predispositions to conduct scientific and teaching activities,
- 6) documented academic achievements acquired from academic studies or professional career,
- 7) English skills at least B2 level,
- 8) experience in conducting qualitative research and/or experience in the problem area of the project (cement industry, chemistry and physics of cement and its products, practical experience in related industries),
- 9) basic skills in data collection and analysis,
- 10) interpersonal competences and skills of organization, teamwork and time management.

Optional: engineering experience, practical knowledge of the relevant industry, participation in social scientific research.

#### **The candidate must fulfil the following requirements defined in the Polish Law on Higher Education:**

- 1) possesses qualifications defined in the Law,
- 2) has full legal capacity,
- 3) has not been punished by final court judgement for intentional offence,
- 4) enjoys full civil rights.

#### **EXPECTATIONS/OBLIGATIONS OF AN ASSISTANT:**

- 1) carrying out research on the topic of DC Project 8: Social life of calcium carbonate cements:
  - a) gathering qualitative data during field research (observations and interviews),
  - b) desk research,
  - c) coding and analysis of qualitative data,
  - d) organization of validation workshops,
  - e) participation in work on a scientific monograph reporting the results,
  - f) completing research internships at HOLCIM, Heidelberg Materials, CHRYSO, CNRS and the University of the Basque Country UPV/EHU,
  - g) preparation of manuscripts for two scientific publications in international journals as first author or corresponding author.
- 2) participation in popularizing the results of the CONTRABASS doctoral network within social and educational platforms,
- 3) participation in the CONTRABASS doctoral network within MSCA, including participation in summer schools,
- 4) obtaining the status of a doctoral student of the AGH University Doctoral School by the end of 2024 (failure to obtain the status of a doctoral student of the AGH University Doctoral School by the end of 2024 will result in termination of the employment contract),
- 5) timely implementation of the educational program at the AGH Doctoral School, including the implementation of the individual research plan,

- 6) close cooperation with people promoting the doctoral dissertation and the project manager.

**SELECTION PROCESS:**

The recruitment process involves two meetings. During the first meeting, the candidate has the opportunity to get to know the promoters and the project manager, and use their help to prepare a draft of future individual research plan. During the first meeting, it is also confirmed whether the person meets the MSCA requirements. The second meeting takes place before a committee consisting of the promoters, the Head of the Department in which the person will be employed and the consortium coordinator. Meetings are held remotely.

The committee evaluates candidates on a point scale from 0 to 100, taking into account the competences to carry out specific tasks in the research project and the candidate's previous achievements:

- 1) scientific experience and/or practical experience related to the research area (we treat practical knowledge, experience in industry and skills in the field of social research as equivalent) (40%),
- 2) previous academic experience – participation in scientific conferences, academic research, possibly publications (10%),
- 3) interpersonal competences and other skills useful in carrying out tasks (20%),
- 4) draft of an individual research plan (30%).

**DOCUMENTS REQUIRED:**

- 1) Letter of application,
- 2) Curriculum vitae,
- 3) Personal questionnaire,
- 4) Copies of diplomas and other certificates confirming qualifications and experience gained (list of possible publications, research projects, participation in conferences, training and internships),
- 5) Document confirming language knowledge at least B2 level (otherwise the assistant will be required to pass the internal AGH test).
