Applying for both international as well as national research will belong to the scope of your duties. As a part of your research activities, you will be developing international partnerships with the scientific units as well as with stakeholders and industrial partners.

- 5) experience in carrying out scientific-research projects,
- 6) experience in acquiring funds for scientific research and managing research projects,
- 7) experience in international partnerships,
- 8) participation in scientific conferences,
- 9) exemplary excellent ethical attitude (accordant with www.agh.edu.pl/o-agh/dokumenty/inne/kodeks-etyczny-agh),
- 10) knowledge of English at B-2 level at least.
