DESCRIPTION (field, expectations, comments, requirements):

The position is to conduct research within the PRAGMA project, funded by the European Research Council (ERC; grant agreement 101002854). In particular, the project focuses on algorithms and computational complexity of elections, including multiwinner elections, participatory budgeting, analysis of distances among elections, and game-theoretic aspects of elections.

REQUIREMENTS:

- 1) a doctoral degree in computer science, mathematics or a related discipline,
- 2) the above-mentioned degree must be recognized in Poland,
- 3) published scientific results in the areas of algorithms or computational complexity (results connected to computational social choice will be a strong plus),
- 4) the candidate should have organizational achievements and demonstrate active participation in conferences and symposia,
- 5) proficiency in the English language (at least on the B-2 level).

DOCUMENTS REQUIRED:

- 1) application, cv, personal questionnaire,
- 2) copy of diplomas or other certificates confirming qualifications,
- 3) a document confirming knowledge of English at the required level,
- 4) cover letter containing a short summary of the scientific results achieved so far,
- 5) information about organizational activities and a list of conferences and symposia in which the candidate participated,
- 6) list of publications.

Documents must be submitted electronically by email to joannab@agh.edu.pl (scanned copies of signed printouts of the application documents are accepted).

The AGH University of Krakow will be the candidate's main place of employment.
