- 1) PHD degree in discipline culture and religion studies or appropriate according to the previous classification of fields and disciplines,
- 2) predispositions to conduct scientific and teaching activities,
- 3) documented scientific achievements in the field the culture of the 20th and 21st century and studies of boundaries of culture and technology,
- 4) documented knowledge of English at least at B-2 level, within the meaning of the Council of Europe's Common European Framework of Reference for Languages (candidates who are not Polish citizens should present a certificate of at least C-1 level).

DOCUMENTS REQUIRED:

- 1) application, CV, personal questionnaire,
- 2) copies of diplomas and other certificates attesting to your qualifications,
- 3) proof of English language skills at least B-2, in the case of foreigners, a document confirming knowledge of the Polish language at least level C-1,
- 4) a list of publications, research projects, conferences, trainings sessions and internships, as well as teaching and co-learning activities carried out to date,
- 5) a short research proposal - a 3-5 page short description of a research project (including a research problem, objectives, research methods and their expected results), which the candidate may submit in the form of a grant application and implement as part of future employment at WH AGH.
