6. theoretical and practical preparation in the area of digital signal processing, machine learning and optimization techniques,
7. practical knowledge of programming in C, C++, Python, Matlab environment,
8. proficiency in acoustic, speech, video and telecommunication signal processing,
9. presentation at prestigious international conferences (e.g. INTERSPEECH) dedicated to acoustic or speech signal processing,
10. high proficiency in audio signal enhancement (e.g. noise reduction) and speech processing/analysis,
11. experience in scientific work in research projects,
12. great team-working skills,
13. passion for scientific and research work,
14. knowledge of English at least B2 level,
15. proficiency in Polish language,
16. certificate of completed pedagogical training or readiness to complete such a training after starting an employment,
