We expect the candidate to provide the following:

- PhD (or higher degree) diploma in one of the following disciplines: discipline of management and quality studies/economics and finance or discipline of management science/economics/finance according to the previous classification of fields and disciplines of science;
- Research interests focused on the application of statistics, econometrics and forecasting methods in social sciences, in management, economics and finance in particular;
- Proficiency in Polish and English, both spoken and written, due to the necessity to run classes and publish research works in both languages;
- Research output in the field of management and quality studies or in economics and finance;
- Experience in teaching classes at higher education institutions;
- Team work skills;
- Experience in applying for funds for research projects in national or international contests and the participation in teams realizing such projects.

2. Specification of the terms and conditions of employment and authority associated with the position.

The job offer concerns a position in the Division of Forecasting and Quantitative Analyses at the Institute of Management in the Faculty of Organization and Management of the Lodz University of Technology. Full-time position. The job is expected to start in October 2024 (possibly March 2025).

3. Description of the expected responsibilities and duties.

A person employed as an assistant professor (adjunct) in the group of the research and teaching staff will be required to conduct research in the discipline of management and quality studies or interdisciplinary research embracing the discipline of management and quality studies, present them, publish the results, and conduct, ongoing reporting in this regard, resulting from the university regulations.

The scope of tasks also includes conducting classes, computer labs and lectures in the area of statistics, basics of econometrics, operations research and forecasting, in both Polish and English, preparing required







materials, and participating in other didactic activities indicated by the Head of the Institute or resulting from internal regulations. The employee's duties also include current organizational works, and activities related to the operations of the University.

Data Privacy Statement for job candidates

Pursuant to Article 13(1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation, Official Journal of the EU L 119/1), hereinafter referred to as "GDPR", we inform you as follows:

- 1) Lodz University of Technology with the registered office in Lodz is the Controller of your personal data;
- 2) We have appointed a Data Protection Officer to supervise the compliance of personal data processing, who can be contacted in matters concerning the protection of your personal data at the following e-mail address: iod@adm.p.lodz.pl; telephone number: 42 631 2039; or in writing to the address of our registered office: Lodz University of Technology, Żeromskiego 116, 90-924 Łódź;
- 3) As the controller, we will process your data for the purpose of the recruitment process for the position indicated, based on your consent (Article 6(1)(a) GDPR);
- 4) You have the right to withdraw your consent to the processing of your personal data at any time, but such withdrawal shall not affect the lawfulness of the processing effected on the basis of your consent prior to its withdrawal:
- 5) You have the right to lodge an objection against the processing of the data as set out above at any time. We will cease to process your data for these purposes unless we can demonstrate that there are compelling legitimate grounds for us to do so which override your interests, rights, and freedoms, or that your data will be required for the possible establishment, assertion, or defense of claims;
