DESCRIPTION (field, expectations, comments, requirements):

A full-time job as an adjunct in a group of research staff at the AGH Space Technology Centre.

You will be responsible for organizing a space biology laboratory. The responsibilities will also include establishing and implementing a research program based on innovative thinking and scientific excellence complementarity with the currently available specialized knowledge in the fields of space biology, as well as modeling biological systems, including genetic changes occurring under the influence of the space environment. The scope of your duties will include implementing an international research program regarding the possibilities of sustaining biological life in the space environment.

You will be responsible for securing funding for projects based on national and international funds, including financing from the European Research Council, FNP, NCN, and others.

As part of research activities, you will develop international partnerships with scientific units, including NASA AMES, ESA ESTEC, and stakeholders (POLSA), as well as industrial partners both domestically and abroad.

Subject area: space technologies, biomedical engineering, space biology

We offer full-time temporary employment (1 FTE) from 05.08.2024 to 31.12.2025 with the possibility of an extension.

REQUIREMENTS:

- 1) minimum doctoral degree: biological sciences, or medical sciences, or animal science,
- 2) declared field of science: biomedical engineering,
- 3) documented significant scientific achievements in the area of biomedical engineering, or biological sciences, or space biology (astrobiology),
- 4) documented research fellowship at a foreign university or another equivalent research unit (minimum period of 2 years),
- 5) experience in carrying out scientific-research projects,
- 6) experience in acquiring funds for scientific research and managing research projects,
- 7) experience in international partnerships,
- 8) knowledge of the scientific environment in the field of space biology,
- 9) participation in scientific conferences and symposiums,
- 10) exemplary excellent ethical attitude (accordant with www.agh.edu.pl/o-agh/dokumenty/inne/kodeks-etyczny-agh),
- 11) Hirsch Index ≥ 7 (SCOPUS),
- 12) knowledge of English at B-2 level at least,
- 13) organisational achievements (leading of a scientific organisation, editor in scientific magazine, etc.),
- 14) a candidate has to have citizenship of a country other than Poland,
- 15) a candidate has never been employed at AGH for more than 6 months.

Additional:

- 1) scientific publications with foreign co-authors.

- 2) diplomas or certificates proving the qualifications you have,
- 3) a list of your scientific and organizational achievements, and – optionally a list of your didactical achievements,
