- 4) a list of publications, research projects, conferences, training sessions and internships, as well as teaching and co-teaching activities to date,
- 5) a short research proposal - a 3-5 page short description of a research project (including a research problem, objectives, research methods and their expected results), which the candidate may submit in the form of a grant application and implement as part of future employment at WH AGH.
