**The Academy of Art in Szczecin announces a competition open for the position  
ASSISTANT**

**in the discipline: fine arts and conservation of works of art  
in the Interfaculty Department of Computer Games and Virtual Reality**

**The competition may be entered by persons who meet the requirements provided for in Art. 113 of the Act of July 20, 2018 - Law on Higher Education and Science (consolidated text, Journal of Laws of 2020, item 85, as amended) and meet the following qualification criteria:**

**Necessary qualifications:**

- holding a master's degree,
- artistic achievements in the field of visual arts and conservation of works of art, with particular emphasis on virtual reality,
- experience in working with *Unreal Engine*.

**Additional qualifications to be assessed:**

- teaching experience related to the use of the above tools and skills,
- artistic and/or teaching achievements related to the use of the above tools and skills,
- professional and/or artistic experience related to computer games and/or virtual reality,
- professional and/or artistic achievements related to computer games and/or virtual reality.

**Required documents:**

- application for participation in the competition,
- professional CV and personal questionnaire,
- a copy of graduation diplomas,
- description of scientific and artistic achievements supported by documentation,
- a statement that the Academy of Art in Szczecin will be the primary place of work,
- a declaration pursuant to Art. 113 of the Law on Higher Education and Science,
- any additional information (in the form of documents or publications that may be of importance in the assessment of additional skills related to the award of the competition),
