- The competition is open to persons who meet the requirements set out in Article 113 of the Act of 20 July 2018. - Law on Higher Education and Science (consolidated text Dz. U of 2020, item 85 as amended) and meet the qualifying criteria indicated in the competition.
- The competition is the first stage of the employment procedure for the position of an academic teacher, and its positive result is the basis for further proceedings

#### REQUIREMENTS:

- having at least a master's degree in vocal studies,
- documented, significant achievements in artistic activity,
- documented experience in working in artistic teams,
- knowledge of English enabling classes to be conducted in English,
- condition for foreigners - fluent knowledge of the Polish language at least B2 level,
- Prepared doctoral dissertation at an advanced level

#### REQUIRED DOCUMENTS

- declaration of compliance with the requirements specified in Art. 113 of the Act of July 20, 2018, Law on Higher Education and Science;
- application for employment addressed to Her Magnificence Rector of the Academy of Art in Szczecin;

- certified copies of documents confirming obtaining a master's degree in the discipline of Vocal Studies. In the case of documents prepared in a language other than Polish, a certified translation of the document into Polish and a certificate are required
- description of artistic achievements supported by documentation, portfolio,
- a statement that the Academy of Art in Szczecin will be the primary place of work,
- any additional information (in the form of documents or publications that may be important in assessing additional skills related to the outcome of the competition).
- A clause of consent to the processing of personal data related to the recruitment procedure, necessary for the implementation of the recruitment process and after its completion, conducted by the Academy of Art in Szczecin based in Szczecin in accordance with the Act of May 10, 2018 on the protection of personal data (Journal of Laws of 2018, item 1000, as amended)".
