- 4) experience in teaching,
- 5) active participation in scientific conferences and symposia,
- 6) organizational experience,
- 7) knowledge of English (B2 level at least),
- 8) proven knowledge of the Polish language at the C1 level, if it is not the mother tongue,
- 9) expertise in PROLOG and nuclear techniques will be an advantage.
