REQUIREMENTS:

- A doctoral degree in the field of engineering and technical sciences, in the discipline of environmental engineering, mining and energy or materials engineering obtained in the year of employment or within 7 years before January 1 of the year of employment. This period may be extended by the time spent on long-term (over 90 days) documented sickness benefits or rehabilitation benefits due to incapacity for work. Additionally, this period may be extended by the number of months of leave related to the care and upbringing of children granted under the terms set out in the Labor Code, and in the case of women by 18 months for each born or adopted child, if this method of indicating breaks in a scientific career is more favorable,
- 2) documented scientific achievements (including publications in journals from the JCR database) in the field of materials engineering, physical chemistry and electrochemistry of solid,
- 3) Experience in teaching work,
- 4) The candidate should have general knowledge of solid state physical chemistry, materials engineering and solid state electrochemistry. Additionally, he should have experience in the synthesis of inorganic materials and knowledge of XRD, FTIR, Raman and Moesbauer spectroscopy, XPS, microstructure tests and electrochemical tests of cells,
- 5) knowledge of software : OriginLab, CorelDraw,
- 6) An additional advantage is the implementation of research projects,
- 7) organizational achievements,
- 8) active participation in conferences and symposia,
- 9) predispositions to scientific work,
