6. English language proficiency at least B2 level, as defined by the Common European Framework of Reference for Languages.
7. for foreigners – Polish language proficiency at least B-2 level.

Achievements that are the basis for applying for the above-mentioned position, must be achievements obtained after the award of the academic degree of doctor.

- possesses qualifications defined in the Law,
- has full legal capacity,
- has not been punished by final court judgement for intentional offence,
- enjoys full public rights.
