DESCRIPTION (field, expectations, comments, requirements):

From a candidate for the position of assistant professor is required to:

- Master's degree or a Master's degree in engineering in the field of exact and natural sciences, specifically in the discipline of Earth and Environmental Sciences, obtained after December 31. 2011 (IDUB Regulations action 21).
- The candidate is not currently or has not previously been employed in the position of an AGH research assistant financed by a subsidy (IDUB regulations action 21).
- Documented scientific achievements resulting from higher education, doctoral studies, or professional work related to the discipline of Earth and Environmental Science.
- Documented experience in research work, including laboratory and geological fieldwork.
- Documented knowledge of laboratory procedures for the separation of silica phases from sedimentary carbonate-silica rocks.
- Documented ability to recognize fossils of siliceous microorganisms in microscopic preparations.
- Documented participation in domestic and international scientific conferences.
- Documented knowledge of English at a minimum B2 level.
- Knowledge of the Polish language required (candidates who are not Polish citizens should attach a certificate of Polish language knowledge at least C-1 level),
- Exemplary ethical conduct (in accordance with <https://www.agh.edu.pl/o-agh/dokumenty/inne/kodeks-etyczny-agh>).

The candidate must fulfil the following requirements defined in the Polish Law on Higher Education:

- possesses qualifications defined in the Law,
- has full legal capacity,
