From a candidate for the position of assistant professor is required to:

1. PhD degree in the discipline of Earth and Environmental Sciences or related field,
2. Documented scientific achievements in the field of Earth and Environmental Sciences,
3. Good knowledge of LA-ICP-MS and LIBS techniques,
4. Documented research achievements using LA-ICP-MS method,
5. Documented research stay in a scientific facility outside Poland, dedicated to research utilizing LA-ICP-MS method,
6. Good knowledge of both written and spoken English (at a B2 level),
7. Experience in conducting scientific research projects and commercial projects,
8. Participation in international research projects,
9. Knowledge of software used for data visualization (such as Grapher, OrginPro, Surfer, QGIS) and office software.

The candidate must fulfil the following requirements defined in the Polish Law on Higher Education:

- possesses qualifications defined in the Law,
- has full legal capacity,
- has not been punished by final court judgement for intentional offence,
- enjoys full public rights.
