**DESCRIPTION** (field, expectations, comments, requirements):

REQUIREMENTS:

- 1) PhD degree in the discipline in field of social sciences, or in the field of exact and natural sciences provided that an interest in social science issues can be demonstrated, or in the field of engineering and technical sciences, provided that an interest in social science issues can be demonstrated. The position is provided for a person who has obtained a PHD degree in the year of employment in the project or within 7 years prior to 1 January of the year of employment in the project,
- 2) interest in multidisciplinary modeling of public debates and/or the topic of argument mining. Research and/or professional experience in this field will be an additional advantage. Knowledge of concepts in social sciences, such as public debate models (including deliberative and agonistic models), social media analysis, and argumentation models, will also be considered an asset,
- 3) knowledge and experience in Python programming (at least at a basic level is required), basic knowledge of SQL and JavaScript, familiarity with Python-related tools and concepts. Proficiency in PEP-8, i.e., guidelines for writing clean and readable code, is required. Experience with NLP, deep learning, and data science will be an advantage,
- 4) scientific and organizational achievements,
- 5) active participation in national and international scientific conferences and symposia,
- 6) documented knowledge of English at least at C-1 level, within the meaning of the Council of Europe's Common European Framework of Reference for Languages.

A candidate may be a person who meets the following requirements specified in the Act on Higher Education:

- has the qualifications specified in the Act,
- has full legal capacity,
- has not been punished by a final court judgement for an intentional crime,
- enjoys full public rights.

### RECRUITMENT RULES:

- 2) A person applying for a post-doc position must meet the following conditions:
  - a) obtained a doctoral degree in the year of employment in the project or within 7 years before 1 January of the year of employment in the project.
  - b) the project manager was not the supervisor or auxiliary supervisor of applicant's doctoral
  - c) dissertation;
  - d) obtained a doctoral degree in an entity other than the entity where employment in this position is planned, or completed at least 10-month, continuous and documented postdoctoral internship in an entity other than the entity implementing the project and in a country other than the country of obtaining the doctoral degree;
  - e) will be employed for a period of not less than 6 months;
  - f) during the period of receiving this remuneration, will not receive any other remuneration from funds allocated as direct costs from research projects financed under NCN calls;
  - g) during the period of receiving this remuneration, will not receive remuneration from another
  - h) employer under an employment contract, including from an employer based outside the territory of Poland;
  - i) during the period of receiving this remuneration, will not receive retirement benefits from the social security system.

- 3) a document certifying knowledge of the English language at a level of at least C-1,
