REQUIREMENTS:

- 1) Ph.D. degree in the field of Engineering and technology or Natural sciences,
- 2) experience in scientific research in the field of geoinformatics, computer science or related areas, documented by at least three publications,
- 3) proven experience in the areas (minimum of one):
 - databases,
 - spatial data modeling and analysis,
 - satellite monitoring,
 - remote sensing and photogrammetry,
 - GIS systems,
- 4) readiness for both scientific and teaching work,
- 5) documented knowledge of English at a level of at least B-2,
- 6) knowledge of the Polish language required (candidates who are not Polish citizens should attach a certificate of knowledge of the Polish language at the level of at least C-1).

SIGNIFICANT FACTORS INFLUENCING THE EVALUATION OF THE CANDIDATE WILL BE:

- 1) completed master's degree or doctorate in computer science, geoinformatics or related disciplines,
- 2) experience in conducting didactic classes,
- 3) national and international awards for scientific or student activity,
- 4) experience in international cooperation
- 5) professional experience in the IT industry.

The candidate must fulfil the following requirements defined in the Polish Law on Higher Education:

- 1) possesses qualifications defined in the Law,
- 2) has full legal capacity,
- 3) has not been punished by final court judgement for intentional offence,
- 4) enjoys full public rights.
