DESCRIPTION (field, expectations, comments, requirements):

The competition for positions pertains to the realisation of analyses and research in the fields of organic geochemistry applied to petroleum systems and the reconstruction of paleoenvironmental conditions, transformations of fossil organic matter, and organic geochemistry in environmental studies related to identifying the origins of pollution, assessing site contamination, and tracking the migration of organic substances in the environment. It also involves the experimental evaluation of the impact of thermal transformations on organic matter in environmental and geological samples.

A candidate for the position of assistant professor is required to:

- 1) PhD degree in the field of science: Natural sciences; scientific discipline: Earth and related environmental sciences or related,
- 2) The h-index at a minimum of 3,
- 3) Experience in scientific research in environmental and petroleum geochemistry studies using gas chromatography coupled with mass spectrometry (GC-MS, GC-MS/MS, Py-GC-MS), as validated by scientific publications and presentations at international conferences,
- 4) Knowledge of the experimental hydrous pyrolysis method confirmed by scientific publications and international conference presentations,
- 5) Knowledge of Agilent ChemStation, MassHunter, Chromeleon, Isodat, and Clarity software,
- 6) Active participation in scientific conferences and symposia,
- 7) Organizational achievements,
- 8) Documented knowledge of English language skills of at least at B2 level.
