- 5. experience working remotely with Moodle e-learning platform and MS Teams welcome,
- 6. international teaching experience welcome,
- 7. experience in international online teaching collaboration or other forms of international teaching exchange welcome,
- 8. certificate confirming the knowledge of Polish language at min. C1 level (CEFR),
- 9. qualifications to teach students with disabilities welcome,
- 10. good organizational skills,
- 11. ability to work independently and under time pressure,
- 12. experience in teaching ESP and EAP,
- 13. knowledge of a foreign language besides English and Polish at the level B1 welcome.

- 9. experience as a baccalaureate examiner.

## VIII) The selection process

1. Competition Committee begins working no later than 14 days after the deadline for submission of application documents.

- 2. Formal evaluation of the submitted proposals.
- 3. Call to provide additional or missing documents if necessary.
- 4. Selection of candidates for the interview stage.
- 5. Interviews for candidates who meet the formal requirements.
- 6. The Committee has the right to request external reviews of candidates' work or to ask candidates to conduct teaching assignments with an opportunity for student evaluation.
- 7. The committee has the right to request a reference letter from the previous employer.
- 8. The chair of the competition Committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses. Submitted documents will be sent back to candidates.
