- 7) good knowledge of deterministic and stochastic global optimization methods,
- 8) good knowledge of data analysis and machine learning concepts,
- 9) predispositions and passion towards research and teaching,
- 10) experience in teaching at a university,
- 11) knowledge of English at a minimum level B-2,
- 12) proficiency in the Polish language,
- 13) certificate of completed pedagogical training or readiness to complete such training after starting the job,
- 14) faultless ethical attitude (in accordance with <https://www.agh.edu.pl/o-agh/dokumenty/inne/kodeks-etyczny-agh>).
