Requirements:

- 1) at least PHD degree in the field of social sciences in the discipline of sociology or psychology (or the corresponding disciplines in the previous classifications of fields and disciplines),
- 2) achievements after obtaining a PHD:
 - a. scientific achievements including at least a series of thematically related scientific publications published in scientific journals or a scientific monograph or chapters in books, taken into account in the scientific evaluation,
 - b. activity in scientific and research works (including management of research projects), in the field of basic research and of an implementation nature,
 - significant scientific activity carried out in cooperation with other universities or scientific institutions, in particular foreign ones - documented international cooperation (internships, scholarships, study visits, etc.).
 - d. experience in conducting didactic classes, including lectures, conversation classes and seminars,
- 3) a statement and teamwork skills within research teams and groups,
- 4) knowledge of English at least at the B2 level within the meaning of the Common European Framework of Reference for Council of Europe Language Education (candidates who are not Polish citizens should present a certificate of knowledge of Polish at least at C-1 level),
- 5) willingness to be included in the number of employees conducting research in the discipline of sociological sciences (100% of working time devoted to conducting this activity),
- 6) willingness to conduct research related to the scientific profile of the Department of Society and Technology Studies. In the procedure, preference will be given to people with achievements and activities in research areas consistent with the profile of the Department of Society and Technology Studies. KSSiT specializes in studying interactions between science, technology and society. Currently, a significant part of the research is located in the area of science and technology studies, with particular emphasis on anthropology of infrastructures and feminist STS. Current research projects focus among others on energy transformation, generative AI, and human ecology, design studies (including gender design), disability studies, and public understanding of science. Many of the research projects are carried out in cooperation with engineering sciences. Within KSSiT we are interested not only in basic research, but also in applied research and designing social innovations.

To be considered a candidate you must meet the following requirements set out in the Act:

- 1) you hold the qualifications defined in the Act,
- 2) you have full capacity for juridical acts,
- 3) you have not been convicted for an intentional offence,
- 4) you enjoy full public rights.

- 4) copy of scientific degree diploma, in the case of a foreigner or a person who has been continuously conducting scientific activity abroad for at least the last five years preceding the announcement of the competition, recognition statement from the application https://nawa.gov.pl/uznawalnosc/system-kwalifikator
- 5) documents confirming knowledge of English at level B2 (in the absence of such documents, it is possible to take an exam organized by SJO AGH),
- 6) in the case of foreigners, a document confirming knowledge of Polish at level C1,
- 7) a short (up to 5 pages of standard typescript) proposal of research consistent with the KSSiT profile, which the candidate can carry out as part of employment at the Department or submit it as a grant proposal; the proposal should include the scientific objective of the project, in particular the scientific hypotheses and the scientific problem the candidate will undertake to solve. The document should include significance of research, current state of research field, a research plan, methodology, and reference to key literature.
