DESCRIPTION (field, expectations, comments, requirements):

REQUIREMENTS:

1. habilitated doctor degree in the discipline of culture and religion studies or a corresponding discipline in the previous classifications of scientific fields and disciplines or in the discipline of political and administrative studies or in the discipline of social communication and media studies or in a related discipline in the field of social sciences,
2. achievements after obtaining a PHD:
 - a. scientific achievements including at least a series of thematically related scientific publications published in scientific journals or a scientific monograph or chapters in monographs, taken into account in the scientific evaluation - preference will be given to candidates with achievements: at the intersection of humanities and technology, and in the fields: new media and digital culture and visual/audial culture,
 - b. experience in research projects (managing research projects or scientific teams or conducting tasks as a team member),
 - c. substantial scientific activities in collaboration with other universities or research institution, especially international ones,
 - d. experience in academic level teaching, including lectures and seminars,
3. full research identification with the discipline of cultural and religious studies (dedication of 100% of one's research time in the discipline), scientific achievements similar to the scientific and research profile of WH, i.e. at the intersection of research on culture and technology,
4. active participation in local and international scientific conferences,
5. documented knowledge of the English language at least B2 level (candidates who are not Polish citizens should show a certificate of proficiency of the Polish language at C1 level or higher).

Candidates that can document their competences going beyond the humanities towards science and technology, e.g. research thematically related to the conditions of culture in the era of digital, technological circulation will be preferred for this vacancy.

To be considered a candidate you must meet the following requirements set out in the Act:

- 1) you hold the qualifications defined in the Act,
- 2) you have full capacity for juridical acts,
- 3) you have not been convicted for an intentional offence,
- 4) you enjoy full public rights.

DOCUMENTS REQUIRED:

- 1) Letter of application, CV, personal questionnaire,
- 2) Copies of diplomas and other certificates confirming the qualifications possessed,
- 3) Statement of the English language proficiency at least B2 level, for foreigners statement of the Polish language proficiency at least C-1 level,
- 4) List of publications, research projects, conferences, training sessions, internships and classes taught,
- 5) A short research proposal - a short description of a research project (from 3 to 5 pages) (including the research problem, objectives, research methods and their expected results), which can be submitted by the candidate in the form of a grant application and implemented as part of future employment at WH AGH.
