REQUIREMENTS:

- 1) completed a technical university degree in the discipline of Materials Engineering, in an area related to industrial automation,
- 2) is in the course of doctoral studies in the discipline of Materials Engineering
- 3) knowledge of English at least at B-2 level,
- 4) experience in programming and database development,
- 5) teaching experience (for example, gained during studies at the Doctoral School) in the following areas: programming, database development, automation and robotics and simulation programmes,
- 6) ability to work in research teams, contactability, availability, punctuality,
- 7) predisposition for teaching and scientific work confirmed by scientific publications.

To be considered a candidate you must meet the following requirements set out in the Act:
