DESCRIPTION (field, expectations, comments, requirements):

The requirements for a candidate for the position of language instructor in English in the group of academic teachers employed by the AGH Department of Foreign Languages are listed below.

REQUIREMENTS:

- 1) degree of Magister of English philology or an equivalent degree with proven formal teaching qualification,
- 2) written declaration of readiness to teach full-time and part-time English courses including English for Specific Purposes Course (ESP) and English for Academic Purposes courses (EAP) as offered by the Department of Foreign Languages,
- 3) teaching aptitude,
- 4) documented commitment to work in previous employment,
- 5) highest standards of ethical conduct (Akademicki Kodeks Etyczny AGH),
- 6) completed distance teaching and learning courses would be an asset,
- 7) experience in andragogy, work experience in a similar position in a higher education institution would be an asset,
- 8) formal qualification to teach more than one language would be an asset,
- 9) knowledge of problems relating to language instruction for students pursuing technical degree programmes would be an asset,
- 10) experience in translation and interpretation would be an asset,
- 11)an additional asset will be documents confirming a job candidate's qualifications as well as teaching and organisational achievements

A compulsory part of the competition procedure will be:

- 1) interview with the Directors of the Department of Foreign Languages conducted in person at the university premises,
- 2) successful delivery of a teaching demonstration lesson at the Department of Foreign Languages at AGH University conducted in person at the university premises.

A candidate must meet the following requirements set out in the relevant provisions of law:

- 1) has the qualifications specified in the relevant provisions of law,
- 2) has full legal capacity,
- has clean criminal record that is: has not been convicted of a deliberate offence under a final and binding court sentence,
- 4) enjoys full public rights.

DOCUMENTS REQUIRED:

- 1) letter of application and CV,
- 2) copies of certificates confirming all acquired academic degrees (if the diploma supplement was issued in a language other than Polish, a translation into Polish prepared by a certified translator or translation agency

- must be provided; if you have changed your name after obtaining a degree please enclose an official document confirming the change of name) and your formal pedagogical background,
- 3) documents confirming a job candidate's previous employment history as required here, including employment certificates or certificates that specify the duration of employment and positions held,
- 4) documents confirming a job candidate's qualifications as well as teaching and organisational achievements,
- 5) a written and signed consent to teach classes as part of both full-time and part-time programmes (including weekend programmes) as well as technical and academic ESP language courses. The consent must be signed, scanned and sent in as a PDF document,
- 6) if necessary (as specified in the institutional notice below), a written and signed consent for the processing of personal data other than those indicated in Article 221 § 1 of the Labour Code, included in the application documents. The signed consent should be scanned and submitted as a PDF file.
