DESCRIPTION (field, expectations, comments, requirements):

A full-time job as an associate professor in a group of research and teaching staff at the Faculty of Space Technologies.

The responsibilities of this position will include university-level teaching in the field of space technologies, as well as developing a research program of international standard, focused on innovative approaches and scientific excellence in the area of new ceramic materials for space applications. The program will also involve acquiring funding for the projects based on national and international funds, including funding from industry entities. As part of the research activities, he or she will develop international partnership cooperation with academic units, stakeholders and industry partners, and publicise the results of projects in the areas described above.

Subject area: space missions, new materials for space structures, ceramics for optical device applications, new constructions from ceramic materials for space application.

Full-time, permanent employment starting in August 2025.

REQUIREMENTS:

- 1) at least a doctoral degree (PhD) in the field of Engineering and technology or Natural sciences and academic achievements conferring eligibility for employment as an associate professor in the research and teaching staff group,
- 2) declared discipline of science: materials engineering or physical sciences,
- 3) documented significant scientific achievements in the field of materials engineering, ceramics of materials, synthesis of new materials or physical sciences,
- 4) h-index ≥ 15 (according to Scopus),
- 5) significant research activity carried out in collaboration with other universities or research institutions, particularly international ones,
- 6) experience in scientific and research activities (including leading research projects and grants, managing research teams, or contributing as a key researcher),
- 7) experience in teaching full-time academic courses, including the delivery of lectures, lectures,
- 8) experience in international cooperation,
- 9) participation in scientific conferences,
- 10) exemplary excellent ethical attitude (accordant with: www.agh.edu.pl/o-agh/dokumenty/inne/kodeks-etyczny-agh),
- 11) knowledge of English at B-2 level at least.

Additional beneficial skills:

- 1) habilitated doctor's scientific degree in the field of Engineering and technology or Natural sciences,
- 2) second congressional language.
