An ideal candidate will: Additional requirements necessary 1. hold a PhD degree in biotechnology, molecular biology, for employment (indicated in order of priority) biochemistry, biophysics or any other related discipline of science. 2. have experience in wet laboratory work in protein expression and purification, in human cell biology techniques and have a fundamental knowledge about translating structural biology results into functional biology. 3. have published at least one scientific article in a peer-reviewed journal as the first author (If you have a special reason not to have a publication, e.g. long-term reviewing process, patent application, etc., please mention it in the application); 4. show a good organization skills, can independently plan and carry out experiments, demonstrates excellent group work skills; 5. be proficient in spoken and written English; 6. fulfil requirements stemming from Regulation on awarding funding for tasks funded by the National Science Centre as regards research projects, including: obtained a doctoral degree in the year of employment in the project or in the period of 7 years before January 1, 2025. (This period may be extended by the time spent on long-term (over 90 days) documented sickness benefits or rehabilitation benefits due to incapacity for work. Opus 24: MOLECULAR CHARACTERIZATION OF THE HUMAN MOCS3 THIOLATION PATHWAY, K/NCN/000210.

### Project description

The successful candidate will work on an ongoing NCN-funded project to investigate the specific cellular pathways that are needed to incorporate sulfur atoms into tRNAs. In the proposed project we will shed light on the specific molecular similarities as well as differences between two sulfur carrier proteins and their common activator. We will purify the proteins and analyze their molecular characteristics and activities in the test tube. We will use structural biology methods to

take structural snapshots of the proteins during their reactions to understand their function. We will seek to identify the networks and natural targets of both proteins in human cell lines that will also serve as simplified model systems to understand the contribution of these proteins to human diseases.

The selected candidate will work in dr Anna Biela's team in the laboratory of the group in the Malopolska Centre of Biotechnology, Krakow, Poland.

#### Scope of duties

The candidates duties will be as follows:

- planning the experiments carried out as part of the project;
- collecting and drawing conclusions from the data obtained in order to plan further experiments;
- assisting less experienced members of the project team in other research carried out in the group;
- supervising the daily work of technicians and assisting the PI in the preparation of figures and manuscripts for publication.

The candidate will be involved in validation of biochemical and structural data in human cell lines, conducting experiments with radioactive elements, analysis of protein conjugates using Western blot and mass spectrometry techniques, generation of stable cell lines, as well as immunoprecipitation and determination of protein interactomes.
